APPLICABLE STANDING RULES OF FLATLANDERS SKI CLUB, INC. (FSC)

TRIP PENALTIES:

- 1.1 All TSC and FSC trips will require a minimum deposit of \$50 if the total trip cost is \$1000 or less and \$100 if the total trip cost is over \$1000. Fifty percent of the deposit will be refunded if cancellation notice is given to the Trip Captain on or before the Trip Captain's published cancellation deadline based on his contract with the ski area or tour operator. Remaining deposits are not refundable after this deadline.
- 1.2 Participants canceling after the deposit refund deadline date will be refunded other trip payments less any penalties or charges imposed by the ski area, tour operator, airline, TSC and/or FSC. Any participant who fails to make the final payment by the published deadline for the trip will be deemed to have canceled.
- 1.3 All cancellation notices must be in writing and dated when delivered to the Trip Captain. If the cancellation notice is mailed, the postmark will serve as the effective date.
- 1.4 Participants eligible for a deposit refund will be refunded no later than thirty days after cancellation notice is received. Refunds of other payments will be made after all penalties and payments can be calculated and verified by the Trip Captain and Treasurer. In some cases this may be after the trip is complete, but must be done as promptly as possible. In no case will the participant be responsible for any penalties that have not been caused by his withdrawal from the trip.
- 1.5 No transfer of deposits or payments from one trip to another trip will be allowed. No transfer of deposits or payments from one trip to another trip will be allowed.

2. NO SHOW:

- 2.1 If the Club encounters a cancellation situation prior to the departure of a trip, the trip participant is entitled to recover the entire cost of the trip less charges incurred by the Club as a penalty for cancellation of lodging, transportation, operating expenses and/or other commitments made on behalf of the trip participant. Refunds to any trip will be made upon receipt by the Club of the total refund due the Club by the resort, airline and/or other entity or as approved by the Board.

3. RESTRICTIONS:

- 3.1 Allowing a non-trip participants to occupy any rooms as a non-registered guest is strictly prohibited, and in violation of Club policy.
- 3.2 The illegal use of controlled substances and/or alcohol during Club trips, or any other official Club function, is in violation of Club policy and is strictly prohibited.
- 3.3 No substitution of trip participants shall be allowed without the knowledge and approval of the Trip Captain. New additions to the trip shall come from that trip's waiting list. The Trip Captain shall make all substitutions.
- 3.4 It is the policy of the Club not to allow the active solicitation of the general membership at a Club function or in the Club publication for any other than Club sponsored trips or activities without the consent of the Board.
- 3.5 No person may participate in a Club sponsored trip, or participant paid activity, without first completing a written and signed Release of Liability.
- 3.6 No person may sign up on a waiting list for a Club sponsored trip without being a member in good standing. A trip must be full before a waiting list can be started.
- 3.7 A Club officer, Director or Director(s) of Trips shall not accept a gratuity in excess of \$25 from a vendor without giving notice to the Board.

4. NON-SKI TRIPS / ACTIVITIES:
